Dear Professor Kelly

Please treat this letter as on the record. We reserve the right to publish it, along with your answer, or the lack of one.

The Australian Medical Professionals Society has been compelled to conduct its own inquiry into the excess deaths found in the all-cause mortality rates. These numbers are alarming. Ethical doctors are gravely concerned about what is happening to the Australian people. We are being approached by thousands of professionals and ordinary people, often damaged patients, who are not happy with the very weak existing explanations.

Powerful temporal associations with the vaccine rollout cannot be ignored when they are placed alongside the record number of notifications to the TGA adverse event database. Facts are emerging and nothing is going to stop this information tide; a case in point is the international interest in the illegal DNA contamination of mRNA COVID-19 vaccines. There are too many independent doctors and scientists reaching similar conclusions: that the biological effects of the mass vaccination program are at the root of this global phenomenon.

On September 27 2023 we invited you to submit a paper to the AMPS inquiry. We are disappointed you neither attended nor brought a paper for review and inclusion in our proceedings.


As part of the inquiry, invitations to attend were extended to every Australian politician, both state and federal. The final document is now published in a book titled *Too Many Dead: An Inquiry into Australia's Excess Mortality*, and every politician in the country will soon have their own copy. You will have yours in the mail shortly.

We note with interest the Prime Minister's coming national apology to victims of the drug Thalidomide (<https://www.medicalrepublic.com.au/national-apology-for-thalidomide-survivors/100872>), where an estimated ten thousand children were seriously injured or killed. Slow justice is no justice.

From the website:

A 2019 senate report found that the government had a “moral obligation” to support Australia’s thalidomide survivors and that it had never fully accepted the role it played in the tragedy.

The irony of this is not lost. There is more apologising to do, on the basis of fully available (and ignored) science. We are now in a position where several times that number of Australian people of all ages have been equally damaged, from a time beginning in about March of 2021.

The Queensland experience informs our understanding of what really happened. There was no COVID in that state at the time the excess death rates rocketed. You will find full explanations of this in the book.

Among medical people there are large numbers of the aware but silent, and these are growing as people step aside from the undue influence of drug-company research. As individual practitioners they are afraid to speak out about the serious safety signals of harm. They are coming forward to us, and they are losing their fear.

It is time for this medical suppression to cease. Our database holds over 3,600 case histories and peer-reviewed studies of adverse effects from the COVID-19 vaccines. Bear in mind that this book contains less than 1% of the evidence at our disposal.

We now ask for a response from you within 14 days to the scientific evidence we have collated and presented in our publication. We would also like a meeting with you to discuss our findings.
