**MEDIA RELEASE – *for immediate release*****AMPS Supports the Call for an Immediate Moratorium on ‘mRNA Vaccines’**

We, the undersigned, on behalf of AMPS (Australian Medical Professionals' Society), strongly support and echo the recent statement made by Dr. Aseem Malhotra – a UK-based cardiologist and chief medical advisor to Robert F. Kennedy Jr's MAHA (Make America Healthy Again) alliance – calling for an immediate moratorium on 'mRNA vaccines' (injectable genetic transfection products).

Our concerns centre around extremely worrying safety signals and exceptionally concerning epidemiological-, medical-, and scientific- data. Adverse effects relate to all major bodily organs and systems, and there appear to be dose- and batch- related correlations, as reported by thousands of peer-reviewed scientific articles.

A forensic analysis of the clinical trial data has found that emergency use authorization (EUA) for these mRNA products was granted despite incomplete mortality and autopsy data. Additionally, the purported efficacy was also not robust due to missing data, and there has unquestionably never been any long-term data. Furthermore, growing evidence also suggests negative efficacy – in other words, the harms from these products, which were inaccurately labelled as vaccines, appear to outweigh any theoretical benefits.

Of note, one of the other rushed-to-market products during the CoViD period was initially defended by various health authorities globally, but especially in Australia, in the face of early worldwide alarm over blood clots; and this product from AstraZeneca was later withdrawn worldwide after hundreds of major adverse reactions and confirmed deaths. Consequently, the credibility of official assurances about the safety of these vaccines, on the basis of correct analyses and integrity, has come under widespread scrutiny.

Therefore, pending transparent, international discourse amongst the scientific communities – in the absence of censorship, cancellation, deregistration, and deplatforming of concerned medical practitioners – **it is our unequivocal position that these mRNA products be suspended on the basis of safety, itself paramount and fundamental to the health and wellbeing of the public.**
